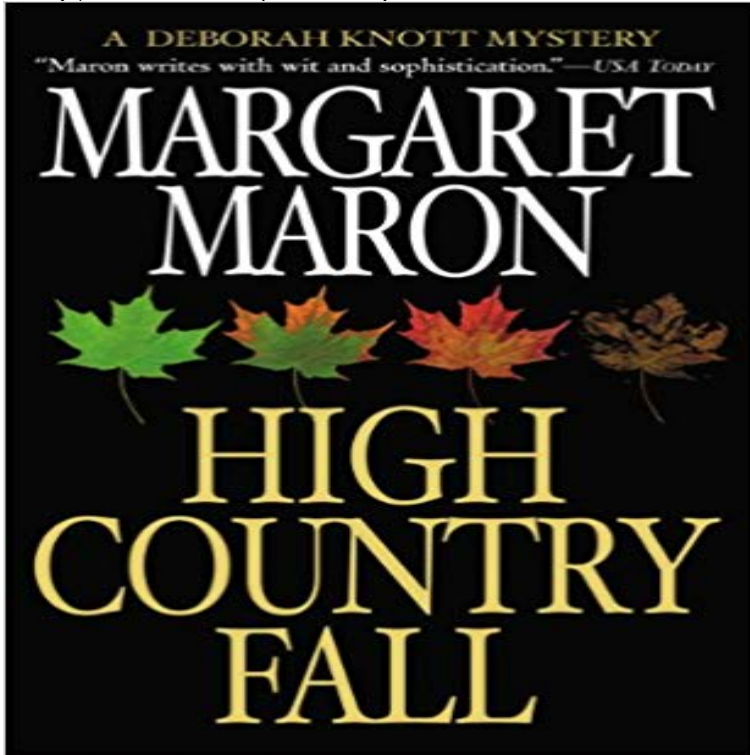


High Country Fall (A Deborah Knott Mystery Book 10)

The twins are convinced their friend is innocent, and when another man is found dead, it begins to appear they are right. The mountain setting plays a huge role here, and Maron does a beautiful job with it, adding local color, as well as delightful regionalisms, to give her characters plenty of personality. When it comes right down to it, however, it's the comfortable ordinariness of Maron's distinctively unheroic heroine that makes this entry in the long-running series so appealing.
